SWOT analysis - Bjelovar-Bilogora County

## **STRENGTHS**

- Advantageous geographical position physical functionally speaking. Bjelovar-Bilogora County is located in the eastern part of the central group of Croatian counties, the most developed area of Croatia, in the key of European hubs and regional routes.
- Rich natural resources
- Preserved environment
- Existence of high educational institutions Technicall high school in Bjelovar Mechatronics and Interdisciplinary Studies Nursing, and Faculty of Economics Rijeka
- Century old tradition of craftsmanship
- Tradition in manufacturing industry metal and food processing
- Tradition of health and spa tourism and hunting tourism Daruvar Spa optimal combination of natural factors and the most advanced procedures in the treatment of rheumatic diseases, medical rehabilitation and physical recreation. First mineral spring was regulated in year 288 BC, and their temperature averaged 46.7 degrees Celsius. Hunting is also known for its quality with the trophy hunting of wild animals.

- The county has nearly 90% covered gas network as compared to other infrastructure in the county adequate
- Low prices of land in business zones the average price of land within the municipal equipped business zones in the county is about 30,00 HRK/m<sup>2</sup>

 Incentives for investors – do not pay municipal fees, exemption from payment of municipal contributions, do not pay taxes at the parts, exemption from fees for certain kw hours of electricity

#### **WEAKNESSES**

- Insufficient use of natural resources agricultural land and forests
- Negative demographic trends
- Existing track and rail infrastructure is underdeveloped
- Roads in the Bjelovar Bilogora county are at the lower category
- Agricultural population has a very low level of education and is at high age
- Little irrigated agricultural land as a prerequisite of modern agricultural production
- Lack of storage, refrigeration facilities and processing plants for fruits and vegetables
- Inadequate technological equipment in industrial sectors
- Insufficient number of skilled workers in all economic sectors
- Lack of accommodation facilities in tourism
- Non compliance with the educational structure and the economy needs
- High percentage of unemployed who are at a low level of education
- Higher percentage of unemployed female population
- Lack of financial resources and insufficient capacity quarantees for loans
- Lack of specialized and inadequate vocational skilled young professionals
- The average salary the average net salary is much lower ( 77% ) of the amount of average salary in Croatia
- The absence of a dearly defined brand was never clearly define
- The concept of brand counties
- The low level of specialization of labour mismatch skills in the workforce with the needs of the market
- In the county is low spatial and professional mobility of the workforce. Spatial nomobility is related to the problem of public transportation and payment of travel expenses by the employer, while the professional no-mobility related to adult education opportunities and poor motivation for further education and training by both labour and by employers

## **OPPORTUNITIES**

- Use of international and EU funds for regional development
- 17 entrepreneurial zones planned, 7 are in operation
- Benefits in the areas of domestic and foreign investors reduced price of land, exemption from payment of municipal contributions in the first year and other benefits
- Great potential for using renewable energy sources geothermal energy, agriculture fertilizer for the production of energy, the remains of wood, solar energy..
- Cooperation with scientific and educational insitutions, and development of new knowledge and technologies – professional study Mechatronics

- A large number of domestic manufacturers to finalize the product of foreign investors castings, lights, springs, tractors, fire doors, pumps, tool holders for machine tools, containers, values, values for high pressure pipelines..
- Construction of highways, construction of main water supply, railway construction and modernization of existing lines – building the highway Zagreb – Bjelovar – Virovitica will ensure better connectivity with the rest of the county population of Croatia and beyond and create a better infrastructure conditions for entrepreneurs and investors.
