### Metal Industry

Metal industries in which we classify manufacture of fabricated metal products, manufacture of machinery and equipment and transport equipment manufacturing has a long tradition in the area of the Bjelovar-Bilogora County.

Metal industry of Bjelovar-Bilogora County has a significant place in the manufacturing industry as shown by the shares of certain economic categories. In the total number of manufacturing enterprises the metal industry participates with 25.7%, 20.5% refers to the number of employees, in total revenue in manufacturing metal industry participates with 20.8%. The largest share of manufacturing exports after processing the wood fabricated metal products and basic metals and makes 19.2 percent.
